2. Pledge of Allegiance to the Flag.
3. Approval of the minutes of the April 3, 2019 Common Council meeting.

4. Public comment upon matters not on the agenda and other announcements.

Mayor Walsh welcomed new Council member Amy Chandik Kundinger, and congratulated Alderspersons Hansen, Raasch, and Nelson on their re-election. The Mayor said he looks forward to working together to move the City forward. Aldersperson Nelson reported that the City's next mental health outreach session will be held on April 24th at 6:30 PM in the Oak Room at the De Pere Community Center. The topic will be autism spectrum disorder and its impact on families and in schools. Aldersperson Raasch announced that the West De Pere High School "League of Legends" team won the Wisconsin High School Association E-Sports Championship last weekend.

5. Presentation by Sister City student representative Brooke Goehring.

High school student Brooke Goehring shared a presentation on her experience spending her junior year as an exchange student in Amal, Sweden. Brooke graduated from Southwest High School in January of this year. She explained the reasons she chose Sweden, and her connection to the Sister Cities program which led to her placement in Amal. Brooke stated that she is very glad she chose Amal because it provided a very authentic Swedish experience. Brooke shared details about her host family (her host sister studied in De Pere), her school experiences, and extracurricular activities. While in Amal she represented our community by conducting presentations with elementary students, as well as at her own school. She also presented to local politicians, and was featured in a local magazine article about exchange students. Brooke's school sponsored a trip to Brussels to visit the European Union headquarters; while there she was able to

interview the foreign minister. She shared a video presentation of her Amal experience that she created as a school project. Brooke concluded her presentation by expressing her thanks to the Sister Cities community.

Mayor Walsh stated that Brooke is a very determined, articulate and talented young lady, and that De Pere is proud to have her as our first representative for the Sister Cities program.

8. Recommendation from the Board of Public Works to Approve Wisconsin Public Service's Proposal to Relocate the Overhead Electric Utility Line on Ryan Road in the amount of \$40,000 as Part of Project 19-02.

Public Works director Scott Thoresen provided an updated memo to Council members with revised figures for the project; the City's cost is now \$49,327.66.

Alderperson Carpenter expressed concern about spending money on this project when there are others in the City that need funding. He stated in his opinion this appears to benefit Wisconsin Public Service more than the City.

Discussion followed regarding the relative benefits and costs of burying the utility lines versus leaving them above ground. City Administrator Larry Delo stated that it is the City's goal to continue to get them buried because it gives the community a more secure power source during storms.

Discussion followed about the potential for the City to negotiate a different cost ratio with WPS.

Alderperson Carpenter moved, seconded by Alderperson Nelson to amend the motion to propose that the City should pay \$20,000 for the project.

The Mayor stated that he thinks it would be a mistake to set a specific dollar amount, and suggested it would be better to authorize staff to negotiate in general terms. Alderperson Carpenter moved, seconded by Alderperson Nelson to withdraw the proposed amendment.

Alderperson Nelson moved to amend the original motion, to go back to WPS and negotiate a different cost share for the project. The motion failed for lack of a second.

Upon vote, the original motion to approve the recommendation passed 6-2 with Alderpersons Carpenter and Nelson voting nay.

Alderperson Hansen thanked staff for their efforts in soliciting bids for this project, which includes street lighting. He noted that the lights on those roads are over 40 years old, and the City will get better quality LED lights and energy savings.

Council members discussed the motivation for the amendment, with several expressing the opinion that it was unnecessary to specify an exemption for City vehicles. Public Works Director Scott Thoresen reported that staff is now installing additional signs. He stated that the Police Department has eased off a little on enforcement until the new signs are up. City Administrator Larry Delo provided clarification for the Police Department's concerns and stated that it is standard practice throughout the state and country for municipal vehicles to be exempt.

Alderperson Hansen inquired if payments commenced last March, and whether the City has seen any deliverables so far. Finance Director Joe Zegers reported that since the initial payment, OpenGov has delivered 2013-2017 financials. In his opinion the integration piece should make things a lot easier moving forward. With this amendment the City can get daily and weekly updates instead of just on a monthly basis, and can review transactions in the most up-to-date fashion. He reported that they are looking at scheduling the first integration meeting and transfer of data this week.

Alderperson Carpenter requested an analysis of uncontrolled intersections in the City in order to develop a consistent policy for installation of traffic signs. The Mayor indicated that this item will be brought to the Board of Public Works.
